MINUTES:

Large moved to approve the December 3, 2019 Regular Board meeting minutes as presented. Seconded by Bernhardt

Roll call vote: 10-yes, 1-absent. Motion carried.

FINANCIAL REPORT:

The Financial Report was presented to the Board.

Stromberger moved to accept the Treasurer's Report and pay the Accounts Payable. Seconded by Merrihew.

NRCS REPORT:

Andy Keep gave the NRCS report. Andy reviewed the 2021 Local Working Group, including who the group is comprised of and what its responsibilities are. Local Working Group meetings are open to the public and a public notice is published in the papers. Andy would like to have a Local Working Group meeting on Wednesday, February 5th, 2020 at 1:30 p.m. at the NRD office.

Ferryberry moved to approve the NRCS Report of Planning Activity dated January 7, 2020 to include the Conservation Plans as signed for Chase and Perkins County. Seconded by Stromberger.

Roll call vote: 10-yes, 1-absent. Motion carried.

UPPER REPUBLICAN NRD RULES AND REGULATIONS: None.

VARIANCE COMMITTEE:

Margaret and Brent Marvin are requesting a Variance to transfer 77.4 acres from the NW 34-7-39 and 5 acres from the NE $\frac{1}{4}$ 34-7-39 to the NW $\frac{1}{4}$ 35-7-39. After removing the end gun from the NW 35-7-39 they wish to establish a new pivot on the SW 35-7-39 with 97.4 certified acres that will be watered from the NW $\frac{1}{4}$ 35-7-39.

Bernhardt, on behalf of the Variance Committee, recommended approval of the Variance request of Margaret and Brent Marvin to transfer 71.4 certified acres from the NW ¼ of Section 34-7-39 and remove the end gun off of the NW ¼ 34-7-39 that waters 6 acres, for a total of 77.4 certified acres being transferred to NW ¼ 35-7-39, removing the end gun on the NE ¼ 34-7-39 which waters 5 acres and transferring these acres to the NW ¼ 35-7-39, remove the end gun on the NW ¼ 35-7-39 which waters 15 acres for a total of 97.4 certified acres. The 97.4 certified acres will go with a new pivot in the SW ¼ of 35-7-39 which will be watered by the well in the NW ¼ 35-7-39. The carryforward on the NW 1/4 35-7-39 will be reduced to 39 inches and the carryforward will remain the same on the others.

Roll call vote: 10-yes, 1-absent. Motion carried.

REPORT OF DISTRICT APPLICATIONS, CONTRACTS, AGREEMENTS:

Terryberry moved to approve the Report of District Applications, Contracts and Agreements dated January 7, 2020 to include the NSWCP applications, well decommissioning applications and the Board of Educational Lands and Funds. Seconded by Bernhardt.

Roll call vote: 10-yes, 1-absent. Motion carried.

Jasper reported that the State did have a meeting with Kansas and Colorado and made a presentation on accounting changes.
