Terryberry moved to approve the NRCS Report of Planning Activity dated December 3, 2019 and to include the Conservation Plans as signed for Chase County. Seconded by Bernhardt. Roll call vote: 10-yes, 1-abstent. Motion carried.

# **VARIANCE COMMITTEE:**

Kerry Bernhardt gave the Variance Committee report. 323 Enterprises LLC is requesting a variance to transfer 130.6 certified acres out of the rapid response area from NE 4-5-39, Chase County to the SE <sup>1</sup>/<sub>4</sub> 4-4-38, Dundy County. They are requesting to transfer all 130.6 certified acres instead of the 108.56 allowed based on historical use and to drill a new well on the SE 4-4-38, which is a dryland quarter and convert the well in NE 4-5-39 to a livestock well.

Bernhardt on behalf of the Variance Committees recommendation to approve the Variance request of 323 Enterprises LLC with the following recommendations: Transfer 125 certified acres from the NE ¼ 4-5-39, Chase County to the SE ¼ 4-4-38, Dundy County, no end gun, 13" allocation with no carryforward, no pooling unless within floating township, decertify 5.6 acres, and drill a new well on the SE 4-4-38, Dundy County and decommission the well in NE 4-5-39 or convert to a livestock well.

Discussion.

Roll call vote: 9-yes, 1-no, 1-absent. Motion carried. Voting yes, Bernhardt, Kunkel, Merrihew, Martin, Schroder, Stromberger, Stroup, Terryberry and Turner. Voting no: Large, Absent: Schroder.

Margaret and Brent Marvin are requesting a Variance to transfer 77.4 acres from the NW 34-7-39 and 5 acres from the NE ¼ 34-7-39 to the NW ¼ 35-7-39. Then after removing end gun from the NW 35-7-39 will establish a new pivot on the SW 35-7-39 with 97.4 certified acres that will be watered from the NW ¼ 35-7-39. This will be an agenda item for the January Board meeting for Board action.
